- 9. Do not defeat the safety purpose of the polarized or grounding-type plug. A polarized plug has two blades with one wider than the other. A grounding-type plug has two blades and a third grounding prong. The wide blade or the third prong are provided for your safety. If the provided plug does not fit into your outlet, consult an electrician for replacement of the obsolete outlet.
- 10. Protect the power cord from being walked on or pinched, particularly at plugs, convenience receptacles, and the point where they exit from the apparatus.

- 22. The loudspeakers can generate considerable energy. When placed on a slippery surface such as polished wood or linoleum, the speaker may move due to its acoustical energy output.
- 23. Precautions should be taken to assure that the speaker does not fall off a stage or table on which it is placed.
- 24. The loudspeakers are easily capable of generating sound pressure levels (SPL) sufficient to cause permanent hearing damage to performers, production crew and audience members. Caution should be taken to avoid prolonged exposure to SPL in excess of 90 dB.

INTRODUCTION

The SW18P is a high-power compact subwoofer that provides extended low frequency response for specific models in the ED series of high performance point source loudspeakers. It is suitable for the use in live music venues, nightclubs, barss houses of worship and for corporate and A/V applications.

The SW18P subwoofer system is equipped with a high power 18" (460mm) transducer capable of long excursion (up to 30mm peakto-peak), controlled by high stiffness Double Silicon Spider as centering suspension that maintains linear voice coil travel even at high output levels. The motor structure features high strength (BL²/Re) with optimized symmetry and excursion controlled by Inner Flux Demodulating Ring. The robust copper 100mm (4") voice coil is wounded in two different layers both outside and inside the coil support, then doubling the coil surface exposed to air cooling and consequently improving the long term thermal capacity of the loudspeaker. Cones are made of very high-stiffness glass fiber reinforced paper, featuring also invisible water repellent treatment. The 15mm phenolic birch plywood cabinet is provided with an M20 pole mount socket to allow two-way ED series loudspeakers to be mounted above on a speaker pole. Recessed handles are provided for easy lifting and handing and the included polyurethane wheels aid transportation, while stacking feet and matching recesses enable secure ground stacks. Two Neutrik[®] speakON[™] NL4 connectors provide input and link connections.
